Please be sure to read all rules. In addition to the following rules, all ABGA and JABGA Sanctioned show rules will apply. By entering the show, you are agreeing to abide by all rules. No unethical treatment of animals will be allowed. This will be monitored and violators will be made to leave with no refunds given.

Entries and Payment:

- 1. Online entries will be closed on 6/18/2020. Entries will be accepted the day of the show. NO late fees will apply. NO REFUNDS.
- 2. Entries will only be accepted on Showman.app.
- 3. Mark entry form if you want electric hook-up for camping at \$25 / day.

Arrival:

- 1. Goats can arrive after 10 am on Friday. Please do not arrive early.
- 2. Breeding registration will be Friday 3 pm 8 pm and Saturday 6:30 am 8 am.
- 3. Market goats and lambs must be registered and across the scales by 2 pm on Friday. Scales will be open 11 am 2 pm.
- 4. All ABGA and JABGA animals must be checked in by 8 am Saturday. No substitutions or late entries will be accepted after this time.

Pens and Shavings:

- 1. Pens will be assigned.
- 2. Pen fees are \$7.00 each. Pen size is approximately 6' x 10'.
- 3. Tack pens (if available) are \$7.00 each. Limit of 1 tack pen per exhibitor.
- 4. Shavings are offered for \$7.00 per bag. Additional quantities will not be available.

Health Requirements:

- 1. All goats and lambs brought on the fairgrounds must be accompanied by a "Certificate of Veterinary Inspection" (CVI) signed by an accredited veterinarian. The CVI must be issued within 30 days of date of show. All animals must be individually identified on the CVI.
- 2. All covers must be removed from the animals to be checked. Please have your health papers ready.
- 3. All ABGA goats must have registration papers and tattoos; all other goats and all lambs must have scrapie tags.
- 4. No goats/lambs showing clinical signs of contagious or infectious disease, including active ringworm, caseous lymphadenitis, sore mouth, foot rot, warts, lice or mange will be allowed to enter the barn or show. If you are asked to remove your animal due to a health issue, NO refunds will be issued.
- 5. Animals may be examined by show personnel, veterinarians, or state-federal personnel.
- 6. Any questionable issues will be decided by Show committee and decision is final.

ABGA and JABGA Registration:

- **1.** ALL ANIMALS MUST BE ABGA REGISTERED TO BE SHOWN IN ABGA and JABGA SHOW. Original registration papers are required to check in, except as noted in ABGA rules.
- **2.** Tattoos must be a complete match to registration papers. Tattoos will be checked on first and second place winners at the conclusion of each class.
- 3. JABGA animals must be registered in member's name only. No family name.
- **4.** JABGA exhibitors must have a 2020 letter from ABGA for showing sibling's goats or you will not be allowed to do so.
- **5.** JABGA exhibitors must have their 2020 JABGA membership card to show at check-in. Digital copies are allowed.

Youth Market and Commercial Doe Additional Rules:

- 1. Show open to any youth 21 years of age and under as of January 1, 2020.
- 2. Market GOATS show first, then LAMBS ending with Commercial Doe.
- 3. All market entries will show together regardless of sex. Does will be allowed to be shown in market goat and commercial doe shows, but may not be shown in ABGA/JABGA shows on June 20-21.
- 4. Market Does are allowed to enter the Commecial Doe show as long as the entries are paid prior to the close of scales.
- 5. Weigh-in is scheduled **until 2 pm Friday**. All market animals will be weighed and divided by weight into classes. Commercial does will be divided into classes by weight and teeth (milk, 2 teeth, and 4 teeth). No reweighs.
- 6. Please be sure to read this entire document as there are other areas that apply to market as well.

Market Showmanship:

Market Goat and Commercial Doe Showmanship will be combined together.

Age division will be determined based on age on January 1st, 2020.

- a. Senior Division- 15-21 years of age.
- b. Intermediate Division- 11-14 years of age
- c. Junior Division- 6-10 years of age
- d. There will be a PeeWee showmanship class 5 and under but it will not be counted in the awards series.

General Rules:

- 1. The KGPA, nor any person affiliated with this organization, assumes any responsibility for accidents, loss or damage to persons, animals or property. Exhibitors shall be responsible for all of the security, safety, and care of their animal.
- 2. No alcoholic beverages, drugs, or other controlled substances are permitted on the fairgrounds by anyone. Exhibitors using alcohol will be directed to immediately remove themselves and their goats from the fairgrounds.
- 3. No Smoking within 20 feet of the barns or show arena.
- 4. No disorderly conduct of any kind will be permitted. No bicycles, skate boards, roller skates, etc. will be permitted in the barns, wash rack or show arena area.
- 5. No animals are allowed to run free on the fairgrounds; dogs must be leashed.
- 6. By entering the show, exhibitors and parent/guardians are agreeing to abide by all rules. It also gives permission for pictures/videos being taken during the show and used for advertising purposes.
- 7. General Liability forms will need to be signed by all exhibitors pertaining to COVID 19. All exhibitors will be showing at their own discretion.

In case of a discrepancy, or for rules not adequately covered, show committee decision will be final.
